Request for Quote (RFQ) for Fiber Installation Materials

Hopkinsville Electric System/energynet (HES), located in Hopkinsville, Kentucky, is issuing a Request for Quote seeking a vendor to supply fiber and hardware for our City-Wide Fiber Completion Project.

The successful bidder will be providing fiber installation materials and temporary warehousing of fiber cable and associated hardware.

HES energynet began installation of fiber in Hopkinsville in 1998. In 2018 we began a more extensive fiber installation in Hopkinsville to serve residents of the City of Hopkinsville with FTTH services.

We are now preparing to complete our Fiber Installation in Hopkinsville. We have fiber designs prepared and ready, we will manage the project internally and request materials as needed by contractors.
